



## **IRFD Publication Agreement and Assignment of Copyright/Permission to Reprint**

The following agreement and assignment must be completed and returned to IRFD before papers can be published.

The procedures and requirements for the publication of papers submitted to IRFD are described below.

It is the policy of IRFD, where legally possible, every paper presented to IRFD and accepted for publication and the copyright therein shall be the property of IRFD. The copyright of the paper must be assigned to IRFD by means of the Publication Agreement and Assignment of Copyright on page 2 of this form; or permission to reprint must be obtained and granted to IRFD. This agreement does not entitle authors or copyright holders to the payment of royalties or any other financial payment from IRFD.

1. If the copyright of the paper is owned by the author(s), the Agreement should be signed and dated by the author(s) at space A. (The author(s) assert(s) to IRFD that he/she/they has/have the moral right to be identified as the author(s) of the work in accordance with Section 201 of US Copyright Law contained in Title 17 of the United States Code.

2. Where the paper has previously been published elsewhere or if copyright of the paper is in the possession of an employer or government agency, the author(s) must obtain and attach to this form written permission to reprint the paper from the copyrights owner. Any permission, licensing, royalty, and other fees involved in obtaining permission to reprint the paper must be paid by the author(s) according to copyright owner's stipulations.

3. For the avoidance of doubt, save in relation to copyright and database rights, no other intellectual property rights, such as patents, that may be referred to or described in the paper shall transfer to IRFD.

4. The party assigning to IRFD copyright and database rights in the paper shall be entitled, without payment to IRFD, to: a) reproduce figures or extracts from the paper with proper acknowledgment to IRFD; b) reuse all or portions of the paper in other works with proper acknowledgment to IRFD; and c) make and have made copies of the paper as published by IRFD for his/her/their/its own purposes but not for sale, provided that any reference to IRFD does not imply endorsement by IRFD of any organisation, its products or its business.

5. If IRFD agrees to publish the paper, but does not publish the paper within two years of agreeing to do so, then the author or organisation that assigned copyright and database rights in the paper to IRFD shall have the right to require IRFD to assign back the copyrights and the database rights in the paper.

If for any reason IRFD fails to publish the paper then the only right and remedy against IRFD of the party that submitted the paper and/or assigned copyright and database rights in the paper to IRFD shall be to require that the copyright and any database rights in the paper are assigned back.
